## **Independent Accountants' Report** **On Applying Agreed-Upon Procedures**

We have performed the procedures enumerated below on agreed upon procedures of Louisiana Corporate Credit Union for the year ending December 31, 2022. Louisiana Corporate Credit Union's management is responsible for the selected accounting records and transactions.

Louisiana Corporate Credit Union has agreed to and acknowledged that the procedures performed are appropriate to meet the intended purpose of evaluating compliance with Rule Compliance Audit Requirements for ACH Transactions. This report may not be suitable for any other purpose. The procedures performed may not address all the items of interest to a user of this report and may not meet the needs of all users of this report and, as such, users are responsible for determining whether the procedures performed are appropriate for their purposes.

### **Procedure:**

This engagement was conducted by a review of the procedures performed by Credit Union management to satisfy the necessary requirements to fulfill their annual responsibilities for the Automated Clearing House (ACH) compliance review as of December 31, 2022. This audit did not include a detailed examination of all transactions and cannot be relied on to disclose errors, irregularities or illegal acts that may exist.

### **Finding:**

We reviewed the Credit Union's 2022 ACH Audit Workbook and supporting documentation completed October 19, 2022. We also reviewed the Credit Union's ACH Risk Assessment. Procedure performed with no exceptions. The Credit Union is in compliance with ACH Rules.

We were engaged by Louisiana Corporate Credit Union to perform this agreed-upon procedures engagement and conducted our engagement in accordance with attestation standards established by the American Institute of Certified Public Accountants. We were not engaged to and did not conduct an examination or review engagement, the objective of which would be the expression of an opinion or conclusion, respectively, on the accounting records and transactions. Accordingly, we do not express such an opinion or conclusion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.
